Williams who stated that he would write the expectations for type of cement, soil compact specs, rebar specs to be passed on to the contractor and these would be checked by an independent expert, and proven to the engineer. He also agreed to additional meetings with the committee. Dave Gale moved to accept the Williams bid, Dave M seconded and it was approved.

The Culvert Inventory Grant has to be completed by October 30th so it needs to be done ASAP. David Sabatini will meet with Turner and go around with him. It should take 2 days. We do not know if Jim and or Ed Hayes will accompany them.

NOTICE.. the bridge at route 125 at the end of the Goshen-Ripton Road will be closed on September18th thru October 13th to complete the new construction.

Paving for the driveway at the the Town Hall will be completed in the next two weeks. Once it is done we must publish the information in our local paper. Motion to accept the bid of R>C>Williams made by Dave M, seconded by Dave G and passed.
